The President stated that if there is an occurrence of this nature again, please let one of the Committee know and the Committee will organise its removal.

### **General Business**

The monthly meeting will be held in the EV Nichols room next door, in the same building as used currently, from February.

Quad bike in for service.

Presentations made to members who attended Wings Over Whiteman.

Ian Johnson requested Warbirds be moved from April 3 to April 17, due to his personal schedule conflicting. Officially moved.

Ross Cant has been pre-emptively informed to update the AWA Calendar.

Next issue of Windsock will have a nomination form for those flying on the day. This is to assist the MC on the PA system when talking about aircraft and pilots. Secretary to Action KAMS Calendar change.

XMAS Party wasn't in Calendar, agreed to have it on the  $3^{rd}$ .of December 2011. Secretary to Action KAMS Calendar change.

Clint West spoke about the gliders flying out of bounds and one flying over 1000ft, when it was lost from sight and crashed. The president stated that the aircraft that was lost, was lost on a hazy day. The membership agreed that the gliders don't go to 1000ft as they are too small to be seen at that height, so over 1000ft seemed very unlikely. The President read the rules about where gliders are allowed to fly and remarked that they are not as restricted as powered models as to where they may fly, but over the clubhouse and carpark were still out of bounds to all models regardless.

Clint further stated that the Glider Tug towing the glider went up and then later came down and flew behind the clubhouse. Approached the Safety Officer and was told to speak to the pilot. Point made by Clint, that this is a safety matter. Committee will investigate this matter.

Clint asked the Committee – Did the member who drove on the path break the path. Secretary stated that a member was seen driving on the path and that damage was noticed later, but we can't be sure that that member caused the damage. Membership discussed barriers of coppers logs and signs. Glenn Baldwin will investigate the cost of logs and posts and present it to the next General Meeting.

Clint asked the Committee – With regard to the Committee Only area of the KAMS Website, whether the password was available to the membership. President stated the area was for Committee records only and was not available as there was often a need for record privacy until published in the club newsletter.

Clint West read his warning letter and By-Law 3.9 regarding Noise to the Meeting and stated that he felt that it had been directed at him and he was being singled out. The President assured him that it had been addressed to him and indeed directed at him, but that he had not been singled out as other members had received letters recently.

Clint stated - I have been flying it at half throttle since returning to the club. On the  $31^{\rm st}$  I did fly at full throttle I admit that. Clint stated that the noise testing equipment doesn't meet rule 3.9, which requires a 7m circle to be drawn and a tripod in the middle of the field and this is why he didn't give the safety officer his aircraft for testing.

The Safety Officer spoke about how he had attempted to conduct a noise check on Clint's aircraft in late November and how he had been actually performing these tests over the last months, this being hand held from 4 points, 7 metres from the aircraft in question. He further stated that Clint had admitted at the time that he already knew that his aircraft was 96db and didn't allow it to be tested stating that the test device required a sock. He stated that Clint had flown the aircraft later that day and it had been quieter due to restraint by Clint on the throttle.

The President spoke about the noise issue and its history in the club at length and made a point that the Shire Council had the ability to shut down our field if we were to get many complaints. The president was asked whether there had been complaints recently and he stated there had been 2 from the usual neighbour, made by telephone directly to him. The President stated that all members should be working towards an 85db noise level with their larger aircraft, as this had been generally accepted as achievable. He further stated that the club committee must act on any valid complaint.

Safety Officer thanked by the membership for his good work.

Eric asked that members who use the BBQ, clean the BBQ after use please.

Clint West believed that Mobile phones' being used on the field was still a problem – extra sign to be erected. Committee to investigate.

Investigation of completing fence line to exclude non flyers from the pits. Committee to consider.


# HAVE YOU BEEN BITTEN BY THE SCALE BUG?
