CONSTITUTIONAL AMENDMENT 1:

That clause 18.7 be deleted from the constitution.

Section 18(7) states:

A person elected to a specific office on Executive Committee shall not hold that same office longer than 2 years consecutively.

Moved: Ken Wansbrough, 2nd Andy Peryer. Vote: 21 for and 2 against. Motion carried.

CONSTITUTIONAL AMENDMENT 2:

To amend clause 28.7.b to enable electronic voting.

Discussion held by membership and considered unnecessary as vote is taken by membership attending special meeting, 75% yes secures a passing vote, not 75% of total membership.

Ken Wansbrough made motion to withdraw his motion to amend clause 28.7.b.

Nigel Molyneux brought up the issue of non-events on Pylon allocated days. President to speak to M. Giggins regarding removal from calendar as no events have been held.


Andy Peryer to investigate possible safe disposal of LIPO Batteries as the field.

HAVE YOU BEEN BITTEN BY THE SCALE BUG?


If you love aeromodelling, you must have dreamt of flying a scale aircraft at some time.

There has been no change to the fees that were in operation last year.

The fees for registering members with the AWA for 2011/2012 are as follows:

Juniors

Make sure that you include the birth date of any members you are claiming to be juniors. A junior is anyone born on or after January 1st 1993.

Pensioners

Also please include the pension number if possible of any new pensioner member. For AWA purposes a pensioner is a person who has a social security pension and a full medical benefit card. The MAAA has removed the pensioner category from its membership types. This means that members that were considered pensioners will now be considered to be senior members. In practical terms this means that on the MAAA card members that were considered pensioner will now be marked as senior. There is no difference in the fees charges because there has been no difference between the MAAA pensioner fee and the MAAA senior fee. AWA will continue to have the pensioner category with a different AWA fee for them. Some pensioner members may notice the difference on the MAAA card and query this.

Insurance coverage

MAAA Insurance coverage will cease for 2011/2012 members on June 30th 2011. Coverage will start again once they rejoin an AWA affiliated club. To document the point at which insurance coverage starts you should issue a properly dated receipt (we recommend that you also include the time of day) which is the only documentary evidence of coverage members have until they receive their MAAA card.

MR1 Forms

It is not necessary to use the official MR1 form. However the information you supply should be complete and in the same order as the official form. Computer printouts are perfectly acceptable. If you wish to Email membership forms please use the email address treasurer@aeromodellerswa.info.

Club Membership Fee

Clubs must also join the AWA and pay a membership fee of \$40.00. Please use the attached form or the form available on the AWA website at http://www.aeromodellerswa.info/forms/membershipregistration.pdf The form still requires six members to be identified but it is not necessary to pay their fees at this time, only the \$40 club membership fee. Ideally clubs should join the AWA before the start of the next membership year.
